Institute has initiated a number of research programs with translational potential and is in the process of seeking industry collaboration to take the leads to the next level. In order to streamline and co-ordinate the activities related to Intellectual Property Rights (IPR) and technology management of the institute, IAV seeks applications from enthusiastic and highly motivated persons with prior experience in biology and biotechnology related IPR management.

Notes:

1. The applications are to be submitted through online mode only. **Those who have submitted the application against the earlier advertisement dated 12.08.2022 need not to apply again.**
2. The applicants are to provide a valid e-mail id along with the applications. All correspondences related to this temporary appointment will be through e-mail only.
3. Only those candidates fulfilling all the essential qualifications, and qualifying the screening by a duly constituted screening committee will be short-listed for further selection process
4. Canvassing in any form is not permitted and any interim enquiry will not be entertained.
5. The position is purely temporary; and selection to the position will not entitle the candidate any claim for future positions at IAV (permanent or otherwise).
6. The selected candidates are required to join within one month from date of appointment order.
7. The Director, IAV reserves the right to decide on any matter related to the selection procedure, including cancellation of the selection process, if circumstances demand so.

Nature and duration of appointment: The position is purely temporary and coterminous with the project. The duration of appointment will be initially for a period of one year. Extension beyond the initial period of appointment of one year will be based on yearly progress evaluation. If the progress is not satisfactory, no further extension will be granted.
