Essential Qualifications

Age : Not more than 24 years as on 1st October 2022

Educational qualifications:

Diploma in Medical Microbiology / Medical Laboratory Technology (the diploma should have been awarded on or after 1st October 2021) from a recognized Board/ University/Institute as a regular full time course in the relevant trade/discipline with minimum 50% marks in aggregate.

Selection Procedure:

Applications will be initially short-listed based on the eligibility criteria. Having the mere qualification will not entail a candidate to be shortlisted. The Institute reserves the right to modify the qualification criteria during short listing. The final selection will be through an in-person interview.

- 2. No. of vacancies indicated above is tentative and may increase or decrease in the relevant categories at the absolute discretion the Director, IAV.
- 3. A candidate should not have undergone Apprenticeship Training earlier or has been pursuing Apprenticeship Training under the Apprentices Act.

- 4. Diploma / Graduation in the subjects as specified against respective Trade / Discipline above will ONLY be considered as eligible qualification. Diploma / Graduation in other than specified Branch / Subjects shall not be considered.
- 5. Candidates holding a qualification acquired through part-time/correspondence/ distance education mode are not eligible.
- In case of non-availability of suitable candidates for the position of Technician Apprentices – I the same shall be filled by suitable candidates from Technician Apprentices – II or vice versa, as per selection criteria and other criteria/parameters.
- 7. Candidates possessing higher professional qualifications such as MSc, PhD or any such equivalent qualification or pursuing higher qualification and having completed the same on or before joining apprenticeship training, shall not be eligible. A declaration from the candidate in this regard shall be obtained at the time of engagement.
- Only those candidates fulfilling all the essential qualifications, and qualifying the screening by a duly constituted screening committee will be short-listed for interview.
- 9. Canvassing in any form is not permitted and any interim enquiry will not be entertained.
- 10. The Director, IAV reserves the right to decide on the number of positions to be filled; and on any matter related to the selection procedure, including cancellation of the selection process, if circumstances demand so.
- 11. **Obligation for employment:** Upon completion of the apprenticeship period, Institute of Advanced Virology shall have **NO** obligation to offer employment to such apprentices **NOR** can an Apprentice claim right for employment on the grounds of completion of Apprenticeship
