NOTICE INVITING QUOTATIONS FOR CONCLUSION OF RATE CONTRACT

Institute of Advanced virology invites sealed competitive quotations from manufacturers/ authorized dealers/suppliers for the supply of laboratory consumables under annual rate contract basis **for the period from 01 July 2023 to 30 June 2024.**

<u>Sl No.</u>	<u>Description of Goods</u>
1.	Chemicals, Reagents, Glass wares, Plastic wares, cell culture wares, PCR and ELISA reagents and kits, Gene blocks, Diagnostics reagents and kits, Oligonucleotides primers and probes, mask, respirator, gloves etc.

2. While quoting, the rates without GST have to be mentioned. GST as applicable from time to time as per Government notification will be paid extra.

3. The BIDDERS are requested to submit the detailed tender in single cover consisting of the price bids and other documents to prove their eligibility to participate in the tender. The documents should be as per the format prescribed in the tender and should be specific to this tender.

4. The bids are to be submitted in the tender box maintained at office of the Administrative Officer, Institute of Advanced Virology, Bio 360 Life Sciences Park, Thonnakkal, Thiruvananthapuram-695317 on or before due date and time mentioned.

5. Earnest Money Deposit: Rs.10,000/- as DD in favour of Institute of Advanced Virology payable at Thiruvananthapuram.

6. Instruction to tenders:

- (i) Tax and/or any other duties/levies where legally permitted and intended to be claimed should be clearly specified in the tender.
- (ii) The quotes offered should be valid for a minimum period of 90 days from the date of opening of the Tender. Quotation with firm prices will only be preferred.
- (iii) Prices are required to be quoted according to the units indicated in the Invitation to Tender. When quotations are given in terms of units other than those specified in the tender form, relationship between the two sets of units must be furnished.
- (iv) Preference will be given to those tenders offering supplies from ready stocks.
- (v) Payment (in normal circumstances) will be made within 30 days of receipt and acceptance of the item at our site. Payment will be made by NEFT. No advance payment will be made under any circumstances.
- (vi) All available technical literature, catalogues and other data in support of the specifications and details of the items should be furnished along with the quote. The products offered should strictly conform to the specifications prescribed by the Institute. Deviations, if any should be clearly indicated by the tenderer in their quotation. The tenderer should also indicate the Make/Type/catalogue number of the stores offered and should provide the catalogues, technical literature and samples, wherever necessary along with the quotations. Test Certificates wherever necessary should also be submitted along with supplies.
- (vii) IAV shall be under no obligation to accept the lowest or any tender and reserves the right of acceptance of the whole or any part of the tender or portion of the quantity offered and the tenderers shall supply the same at the rates quoted.
- (viii) Corrections should be avoided as far as possible and corrections, if any, in the Quotation must be duly attested by the authorized representative. All amounts shall be indicated both in words as well as in figures. Where there is difference between amounts quoted in words and figures, amount quoted in words shall prevail. Quotation must have price for each line item and totaling of the price including taxes and duties should be clearly mentioned.
- (ix) The tenderer should mention the bank details, GST Registration details, PAN number etc in the tender.
- (x) The authority of the person signing the tender, if called for, should be produced.
- (xi) The stores supplied should be covered with minimum of 1 year warranty from the date of supply, installation and commissioning, if not stated otherwise in tender.

- (xii) Earnest Money Deposit/ Bid Security of Rs 10,000/-shall be submitted by way of Demand Draft and should be submitted along with your quote. EMD should be in favor of Institute of Advanced Virology payable at Thiruvananthapuram and valid for 90 days from the date of submission of tender. There will not be any exemption for payment of EMD for MSME/other firms
- (xiii) LD Clause: LD may be imposed @ 0.5% per week after stipulated delivery period subject to a maximum of 10% of the order value.
- (xiv) Award of Contract letter would be issued to the technically qualified bidder offering highest total discount in percentage.
- (xv) The due date can be extended at the discretion of institute.
- (xvi) If the bidder withdraws or modifies or amends its tender or impairs or derogates from its bid during the bid validity period or if awarded the contract and fails to sign the contract or fails to furnish order acceptance or performance security before the deadline defined by the Institute, they will be suspended for the period of time as decided by the competent authority of IAV from being eligible to submit bids for contracts floated by the Institute.

7. **Terms and conditions for submission of Tender:**

- (i) Offers will be accepted only from manufacturers or authorized agents against, who may quote along with authorization valid as on date of submission of bids. Authorized Agents quoting for the supply should attach specific authorization from the manufacturers, failing which the quotation will be summarily rejected.
- (ii) The quotations are to be enclosed with recent price list with catalogue (hard copy and and/or soft copy).
- (iii) The stores supplied should be covered with minimum of 1 year warranty from the date of supply, installation and commissioning, if not stated otherwise in purchase order.
- (iv) Highest possible discount rates offered against the catalogue price (in Indian Rupee) or each brand of items should be quoted in the format prescribed at Annexure I.
- (v) The Bids should be complete in all respects and should be duly signed by the authorized representative. Incomplete and unsigned bids will not be considered for evaluation.
- (vi) If the authorized distributor is supplying the items, an authorization letter from the manufacturer/Principal company has to be submitted along with the quotation, failing which the quotation will be summarily rejected. Offers will be accepted only from

manufacturers or authorized distributors who may quote along with the due authorization valid as on date of submission of bids.

(vii) The firm should have minimum two year experience in supply of similar products to Government Research Institutions. The proof of same has to be attached along with the quotation.

(viii) Prices charged for the stores supplied under Rate Contract should under no event be higher than lowest prices at which the party sells the items to any other organization during the period of contract as per this tender.

(ix) The time required for the supply of items after the release of Purchase Order should also be mentioned in the proposal.

(x) The rate quoted should be all inclusive, ie., inclusive of transportation costs, installation costs etc. and excluding GST. There shall be no change in price structure during the currency of contract except of the statutory levies which are made applicable by the Government through notifications and regulations.

(xi) In case the vendor lowers the price or increase the discount to any other Institute or party, the beneficial rate would be applicable to IAV also.

(xii) The place of delivery of the consignment is at IAV stores, at Bio 360 Life Sciences Park, Thonnakkal, Thiruvananthapuram-695317 and should be between 9.00 AM-5 PM on all working days (Monday – Friday). The Institute will not be responsible for delays/non-delivery, if any, by the courier companies, if items are delivered through courier.

(xiii) This rate contract will be guided by "Fall Clause".

(xiv) The goods will be delivered within four weeks of placement of order or as agreed (Price offered should be inclusive of transportation/delivery/unloading and other associated charges).

(xv) If the supplier fails to deliver the material within the delivery period as specified, IAV may procure such items from alternate sources. The supplier will be liable to the purchaser for any excess costs incurred for procurement of goods or services not delivered in time.

(xvi) Replacements – Damages/Broken/Expired or any other reason which renders the goods of no use to IAV will be replaced within a weeks' time at no cost.

(xvii) IAV also reserves right to test the chemicals and solvents of material for their quality if it so desires, if the items supplied is found to be of inferior quality and grade the

same will have to be replaced by the supplier at their cost within the stipulated time period.

(xviii) In case of emergency, the Institute reserves the right to purchase the item under rate contract through an adhoc contract with another supplier/firm.

(xix) IAV is entitled to place orders up to the last day of the validity of the rate contract and, though supplies against such purchase orders will be effected beyond the validity period of the rate contract, all such supplies will be guided by the terms and conditions of the rate contract.

(xx) IAV will not be liable for any obligation or supplies made unless the Official Purchase Order has been placed by the authorized official.

(xxi) IAV and/or the firm are entitled to withdraw/cancel the rate contract by serving one-month notice on each other. However, once a purchase order is placed on the supplier for supply of a definite quantity in terms of the rate contract during the validity of the rate contract, that purchase order becomes a valid and binding contract.

(xxii) IAV does not guarantee or assure of any quantum of business during the contract period. The order will be issued only if the requirement of such items arises in the Institute.

(xxiii) IAV shall have the right to have parallel rate contracts.

(xxiv) The awarded bidder has to submit the hardcopy/softcopy of price list/CD within one month of issue of Award of Contract.

(xxv) The inability to supply any item should be intimated within a week from the date of release of Purchase Order.

(xxvi) All disputes of any kind arising out in connection with the executing the order shall be referred by either party (IAV or the bidder) after issuance of 30 days' notice in writing to the other party clearly mentioning the nature of dispute to a single arbitrator acceptable to both the parties. The venue for arbitration shall be IAV, Thiruvananthapuram, Kerala, India. The jurisdiction of the courts shall be Thiruvananthapuram, Kerala, India.

(xxvii) The Director, IAV Thiruvananthapuram does not bind to accept the lowest quotation and reserves the right to him, to reject or partly accept any or all the quotations received without assigning any reason.
