IAV invites EOI for the engagement of Insurance Brokers /Firms (licensed & registered from IRDAI with ISO certification) operating in India for providing technical guidance/support for the implementation of Group Medical Insurance Policy for Employees (2023-2024). Scope of Work

1. To assist in acquiring the best quote from the Insurance Company for implementing the Group Medical Insurance Policy for employees of IAV. The RFQ details and detailed terms and conditions will be made available by the Institute.

2. To ensure the implementation of the Group Medical Insurance Policy for employees of IAV with effect from 15.12 .2023.

3. To design and customize the best policy by optimizing the cover and quality in accordance with the demand of IAV for an approximate employee count 23 with dependent count of 50.

4. To adopt strategies to maximize the risk coverage of the policy with minimum premium outgo.

5. Validation and forecasting of additional coverage benefits.

6. To evaluate and analyze the quote price from different insurer and also recommend the best insurer to IAV sticking to the Rules & Regulations.

Eligibility Criteria

1. The Brokers/Firm should be well established with good reputation and must have a fair track record of minimum 5 years in the area of operation in Insurance broking and must have handled the claims of Group Medical Insurance Policy at least during the last 3 years.

2. The Company/Broker/Firm must have its Registered Office in Kerala (Address should be specified in Annexure–A) with a branch/main Office at Trivandrum preferably.

3. The Brokers/Firm should be holding a valid IRDAI license to do General Insurance broking by IRDAI and the license should be in force while submitting the proposal. License validity should not have any gaps since inception of firm.

4. The Brokers/Firm should have an experience in handling Central/State PSU's Group Medical Insurance policy and the experience proof with substantiating documents must be submitted.

5. The Brokers/Firm must have handled the GMC of at least 3 major Companies/ Institute preferably in the government sector.

6. The Brokers/Firm should not have been black listed/barred by any statutory body or Government/PSU's (Declaration in company letter pad with authorized signatory in format Annexure-E.

Terms & Conditions

1. The selection of the Broker/Firm is entirely at the discretion of IAV based on the requirement and as per the criteria set in this EOI.

2. IAV has the solemn right to review the credentials and specification of the EOI submitted by the Brokers/Firm.

3. IAV is not liable for any cost incurred in connection with the preparation of EOI/RFQ by the Brokers/Firm.

4. IAV reserves the right to reject any or all EOI without any reason.

5. The Brokers/Firm have no authority to modify, alter delete or withdraw proposal after the submission.

6. IAV has the right to terminate the assignment of selected Brokers/Firms in case if the performance is not satisfactory.

7. The tenure of the service for the selected Brokers/Firm is during the entire duration of the Policy period which includes the coordination with the TPA also for claim settlement.

8. The selection eligibility of the Brokers/Firm would be decided on the basis of score secured by the Brokers/Firm on the parameter mentioned in (Annexure D) & eligibility criteria.

9. The service rendered by the selected broker/firm shall be free of cost and IAV shall not entertain any request for remuneration/reimbursement from the broker/firm.

10. Prior to the deadline of submission of Proposal, IAV reserves the right to modify the EOI by the way of amendments and shall be posted on the website of IAV and will be binding to all applicants. Prospective applicants hence must visit the website before final submission of proposal. IAV may extend the timelines to accommodate and allow for reasonable time to respond for such amendments, solely at its discretion.

4. A declaration from bidder that they not debarred/disqualified/blacklisted Annexure E.

5. The copy of contract letter towards engagement as Insurance broker issued by clients with a minimum insured strength of 50 each.

6. All other documents in support of the application.

7. The copy of the original license issued by IRDA while granting license and renewal thereof issued by IRDAI from inception, attested by authorized signatory.

8. The copy of the ISO/Other certification, if any.

Submission of Proposal

1. All the application and supporting documents shall be submitted in English language and if required IAV has the right to call for originals of the company documents submitted by the Brokers/Firm.

2. The Proposal shall be deposited in the Tender box which is placed in the Office of Administrative Officer, Bio 360 Life Sciences Park, Thonnakkal, Trivandrum on or before 02.11.2023 at 5.00 pm.

3. The application shall be submitted in the sealed Company envelope only and subscribed as 'EOI for empanelment as Insurance Broker'.

4. The Proposal should be signed by the Authorized signatory to bind the proposer to the Contract. The entire submitted documents are to be signed by the authorized signatory.

5. If the last day of submission of Proposal is declared as a holiday by Act or any circumstance beyond the control of the Institute, the next working day will be deemed to be the last day for submission of the EOI.

6. The application which is submitted after last date and time will not be considered.

7. IAV may invite the Proposer/Broker/Firm for a short presentation and Company commits itself to remain present for the same since one of the marks in Annexure D is categorized for the delivering the quality inputs by the bidder in a presentation.

Application Opening

The application will be opened in the presence of the available applicants on 03 .11.2023 @ 10.00 AM.

The Company representative present for the opening in the above mentioned venue must carry an authorization letter.

Evaluation of EOI

1. All the application would be scrutinized with respect to eligibility criteria, list of documents submitted.

2. Marks given for Point 5 in Annexure - D are based on the presentation made by the applicant. The presentation will be conducted on 03 .11.2023 (same day of opening application) for the Companies who satisfy the conditions mentioned in the EOI document after evaluation of the submitted documents.

3. The applications not meeting the prescribed eligibility criteria will be rejected after the initial evaluation.

4. The qualified applicants who meet the eligibility criteria shall secure minimum 30 marks based on the award of marks as mentioned in Annexure-D.

5. During the process of scrutiny and evaluation of proposal, IAV may, at its discretion, seek clarification from all or any of the applicants. The said clarification shall be responded by the applicants within the stipulated time. IAV may, at its discretion may

take a decision appropriate if the said clarification is not responded by the applicants.

6. The final evaluation will be based on the total marks obtained and the quality of inputs. Based on this the IAV will empanel the Firm as Broker.

7. The selected Broker/Firm shall be informed and will be provided with the empanelment letter.

8. The empanelled Broker will ensure that there is maximum participation in the Bidding process and the maximum possible competitive bid is available and finalized.
