### Selection Procedure:

Applications will be initially screened and short-listed based on the eligibility criteria; essential qualification and documented experience following recommendation of a screening committee. The shortlisted candidates have to appear for a personal interview for the final selection.

**Duration:**

The duration of appointment will be for a period of one year or till date of termination of the project whichever is earlier. The position is purely temporary and coterminous with the project. Extension beyond the initial period of appointment will be based on the yearly progress evaluation. If the progress is not satisfactory, no further extension will be given.

1. Only those candidates fulfilling all the essential qualifications, and qualifying the screening by a duly constituted screening committee will be short-listed for further selection process.
