Superscription: Providing catering service for conference		

- Sealed quotations are invited from experienced firms having the necessary licences towards providing Catering services for the conference to be held at Institute of Advanced Virology (IAV) on 11th July 2025.
- 2. The bidder should have minimum 'three years' experience in providing catering services for similar functions.
- 3. The services are required to be provided for approximately 300 persons. The requirement may increase or decrease based on the registrations for the conference. The bidder should manage the increase or decrease in the requirement at pro-rata basis of the agreed rates.
- 4. The scope of services includes preparation and supply of food/beverages as per the agreed menu, arrangement of serving counters, supply of utensils/ceramic plates/ glass tumbler for serving/ food/ water/ beverages and other items, deploying of sufficient number of serving staff, clearing of used utensils, collection and disposal of organic and inorganic waste generated at site.
- 5. The indicative menu is attached for reference at *Annexure I*. The bidder has to attach the detailed menu being offered along with the financial bid.
- 6. The guidelines issued by the government authorities are to be strictly followed during the preparation and serving of food items. The disposable materials which are not allowed as per govt. regulations should not be used during the event.
- 7. The tenderers may submit the quotations as per the format attached as *Annexure II* and *Annexure III* in their own papers/letter head. The rates offered should be valid for a period of 30 days from date of quoting.

- 8. The technical details such as compliance to the scope of services, experience details, FSSAI registrations, GST certificate are to be submitted along with the quotation.
- 9. The quotations will be opened at the prescribed time in the presence of such of the tenderers or their authorized representatives who may wish to be present at that time.
- 10. The required services shall be provided on the prescribed date and time.
- 11. The rates quoted should be for providing the mentioned services at INSTITUTE OF ADVANCED VIROLOGY, Bio 360 Life Sciences Park, Thonnakkal, Thiruvananthapuram, Kerala-695 317.
- 12. The necessary superscription, due date for the receipt of quotations, the date up to which the rates will have to remain firm for acceptance and the name and address of officer to whom the quotation is to be sent shall be as noted in the table above.

They must fully understand the service requirements and ensure that they are satisfied with all aspects. By submitting a tender, the bidder confirms that they have read this notice and all related contract documents, and that they are fully informed about the scope and specifications of the services, as well as the local conditions and other relevant factors that may affect service execution

- 16. The acceptance of the quotations will be subject to the following conditions:
 - a. Acceptance of the quotation constitutes a concluded contract.
 - b. Withdrawal from the quotation after it is accepted or failure to provide the services within a specified date & time or according to specifications will entail cancellation of the order and obtaining the services at the offeror's expenses from elsewhere, any loss incurred thereby being payable by the defaulting party. In such an event the Institute reserves also the right to remove the defaulter's name from the list of service providers permanently or for a specified number of years.
 - c. No representation for enhancement of price once accepted will be considered during the currency of the contract.

- e. If any license or permit is required for execution of the proposed services, the tenderers must specify the same in their quotation and also state the authority to whom application is to be made.
- f. Any sum of money due and payable to the contractor (including security deposit returnable to him) under this contract may be appropriated by the authorities of the Institute or any other person authorized by the Institute and set-off against any claim of the authorities of the Institute for the payment of a sum of money arising out of or under any other contract made by the contractor with the Institute or any other person authorized by the Institute.
