You are hereby requested to submit your bid in the attached tender form duly filled in all respect along with connected documents in a sealed cover superscribing "**Tender for Design, Fabrication and Installation of stall**" addressed to **The Director, Institute of Advanced Virology (IAV), Thonnakkal, Thiruvananthapuram-695317** on or before **12:00 Hrs on 15th January 2026**. Tender can also be dropped in the Tender Box placed at the administrative section situated at the IAV phase 1A building. **The tenders dropped/delivered at other sections of the Institute will not be considered.**
3. The tenders are to be submitted with an EMD of Rs.5000/- (Rupees Five thousand only) in the form of demand draft in favour of Director, IAV payable at Trivandrum.
4. Pre-bid meeting for discussing the particulars of the tender shall be held at **12:00 Hrs on 9th January 2026** at **IAV campus**.
5. The tenders will be opened at **12:30 Hrs on 15th January 2026** in the presence of the available tenderers or their authorised representative.
6. The tender form and other terms and conditions are placed at the enclosure to this notice.

GENERAL TERMS AND CONDITIONS

1. The event is scheduled from 30th January to 2nd February 2026 at **St. Albert's College, Ernakulam.**
2. Tender shall be submitted in official tender form only. If submitted in any other form the same shall be rejected. Each and every page has to be numbered and no paper shall be detached from the tender.
3. The name and address of the tenderer shall be clearly written in the space provided and no overwriting, correction, insertion shall be permitted in any part of the tender unless duly countersigned by the tenderer. The tender should be filled in and submitted in strict accordance with the instruction laid down herein: otherwise, the tender is liable to be rejected.
4. The tender is liable to be rejected if complete information is not given therein, or if the particulars and data (if any) asked for in the schedules to the tender are not filled in.
5. The tenders will be opened at the prescribed time in the presence of tenderer who may wish to be present, either by themselves or through their authorized representatives.
6. Tenderer should have the experience of organising at least **FIVE** similar functions in the preceding two years (**2024/2025**) at National Level Institutes/Govt. Organizations/ /Corporate institutions. **Proof of experience such as copy of work order / agreement and event pictures etc. to be attached with the tender.**
7. The firm should have valid registration and GST and the copies of the relevant certificate shall be submitted along with the bid.
8. The schedule of items/services required is as per **Annexure 'II'** of this tender form and the evaluation of bid will be on the basis of total bid value. **Institute reserves the right to change the quantity or cancel the item / service required. In that case the amount paid will be based on the items / services actually availed.**

9. Photographs of similar work carried out by the firm shall be attached along with the bid. Representational image of the requirement of the Institute is given at **Annexure 'II-A'** for reference of the bidders.
10. The rates quoted should be on **FIRM & FIXED** basis. The prevailing duties/taxes must be clearly mentioned by the agencies/tenderers, wherever applicable. In case the same is not mentioned clearly, then the quoted rates will be considered as inclusive of all and no additional payment will be applicable towards taxes/duties etc.
11. The final offer is to be quoted in the price bid at **Annexure 'III'** for the items/services as mentioned at **Annexure 'II'**. No modifications will be allowed in the prices quoted once the contract is finalised.
12. Institute of Advanced Virology (IAV) Thiruvananthapuram reserves the right to accept or reject any or all the offer either fully or partly without assigning any reasons and is not bound to accept the lowest bid since due weightage shall be given to several factors besides the financial quote. **The selected firm has to sign an agreement with the Institute regarding compliance with the terms and conditions of the tender.**
13. The Work Order shall be issued to the finalised agency by **Institute of Advanced Virology (IAV) Thiruvananthapuram** and services shall be arranged by the agency as per the time schedule and requirements projected by the institute.
14. The firm / contractor should deploy technically qualified executives who can coordinate as per requirement of the IAV TVM team and can take immediate decisions on behalf of the firm. The name, designation and contact number of the coordinator should also be provided in the tender.
15. The firm / contractor must ensure that the materials being used are of standard quality, dimensions & other parameters and to be quoted accordingly. In case items / services are not as quoted the same shall not be accepted. No payment, claims for such items shall be entertained.
16. IAV shall in no way be responsible for any default with regards to any statutory obligation on the side of vendor/ contractor and will indemnify IAV in case of any damage or liability, which may arise on account of the action of any reason.

17. The stall at the location should be ready at least two days prior to the event dates.
18. The full & final payment shall be made after providing the necessary services based on certification by the concerned authority. The bank account number and other details are to be submitted along with the bills to facilitate the payment through bank transfer. **The institute will reserve the right to impose penalty and make deductions in case of the following: -**
- Non completion of work in time.
 - Deviation from quality and quantity of service/ items as promised.
 - Non disposal of garbage from the venue.
 - Other things which are not specified and may be deemed fit.
